Thank you for your joint letter of 4 September, to the Foreign Secretary about the Responsibility to Protect (R2P). I am replying as Minister responsible for Conflict Issues.

Regrettably, your letter was received by the Foreign and Commonwealth Office after the UN General Assembly Interactive Dialogue on R2P that took place on 5 September. However, as you may already be aware, the UK took that opportunity, as it does every year, to reaffirm its support for R2P and to emphasise the importance of the preventive aspects of R2P. The UK had discussed the UN Secretary-General's report on R2P with a number of other States ahead of the debate and we were delighted at the number of countries that chose to reiterate their support for R2P this year. In line with the UK's commitment to R2P, we continue to work bilaterally, as well as through multilateral organisations that we are members of, including the UN and EU, to ensure States meet their primary responsibility to protect their populations from genocide, war crimes, crimes against humanity and ethnic cleansing; to encourage and assist States, including through capacity-building, to meet that responsibility; and to ensure that the 2005 UN World Summit agreement on R2P is translated into a willingness to act speedily and appropriately in specific cases.

The UK believes that preventing R2P crimes requires taking a holistic approach across the conflict spectrum to embed a culture of prevention through work on conflict prevention and resolution, stabilisation, development, human rights, governance and security. The Government's annual Human Rights Command Paper outlines how the UK's support for R2P is translated into action in different ways and in different circumstances.
