Founded in 1945, the United Nations Association - UK (UNA-UK) is the country's foremost advocate for UK action at the UN; the UK's leading source of analysis on the UN; and a vibrant grassroots movement of 20,000 people from all walks of life.

We are the only charity in the UK devoted to building support for the UN amongst policymakers, opinion-formers and the public. We believe that a strong, credible and effective UN is essential if we are to build a safer, fairer and more sustainable world. We advocate strong government support for the UN - political and financial - and seek to demonstrate why the UN matters to people everywhere.

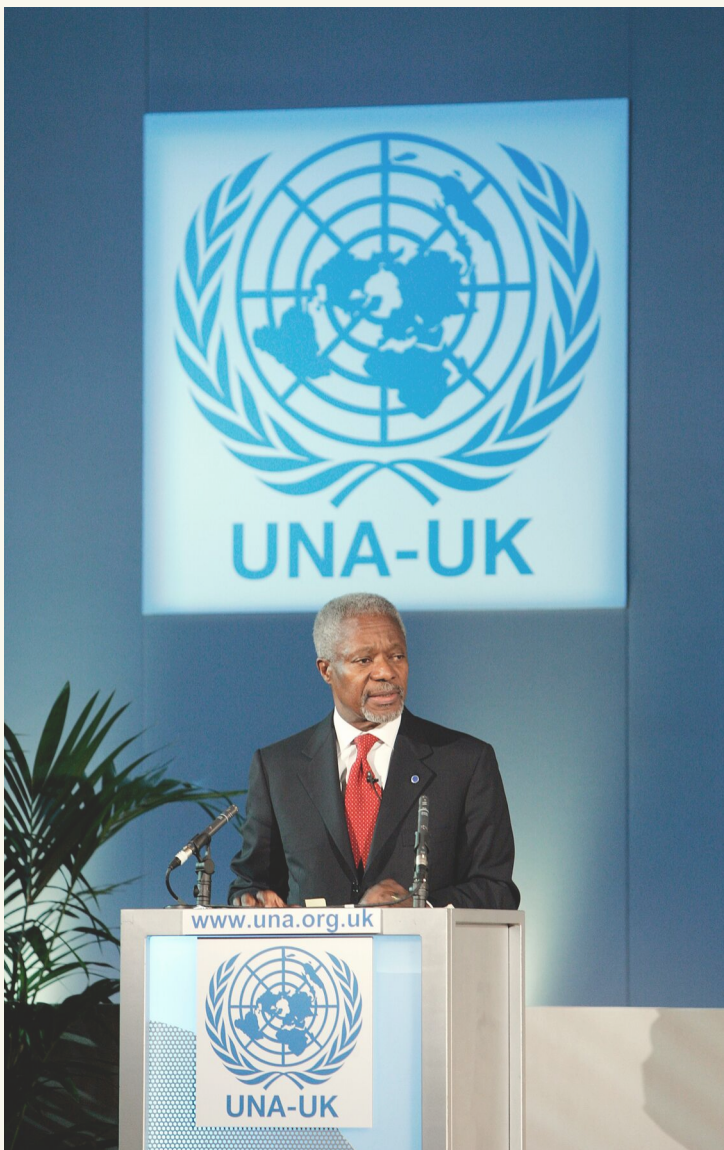

CAMPAIGN WITH US



Over the past few years, we have witnessed a period of unprecedented success for UNA-UK. The 1 for 7 Billion campaign to improve how the UN selects its Secretary-General has led to a more transparent process for the first time in UN history. UNA-UK has also campaigned successfully for UK action on: increased commitments to peacekeeping; and for the UN to be taught as part of the national curriculum. Our student network continues to play an integral role in amplifying our campaigns across local communities and beyond.



Yemen Can't Wait

March 26th marked the 4th anniversary of the Saudi-led intervention in Yemen that has left 24 million people in dire need of humanitarian assistance. Over this four-year period, 3.1 million people have been displaced and approximately 60,000 killed along with large amounts of the populations contracting cholera and facing famine. Most civilian casualties have occurred due to airstrikes by the Saudi-led Coalition, of which the UK has been one of its largest suppliers of weapons.

As the 'lead' country for Yemen on the Security Council, the UK must use its influence with Saudi Arabia to press them to adhere to the current ceasefire and ongoing peace talks.

We ask you to write to your MP and build further momentum in Parliament with our urgent call to action on the situation in Yemen.

Climate Change

By introducing the 2008 Climate Change Act, Britain became a global pioneer as the first country to adopt a legally-binding framework with long-term emissions targets and carbon budgets. More recently the UK has shown leadership in its commitment to net zero carbon emissions by 2050.

From the Youth Strikes for Climate to the Extinction Rebellion protests, the UK public is getting mobilised on climate change and it's starting to get results. Now's the time to build on this and call for increased ambition across all parts of government and society to protect the earth we all depend on.

Mission Justice

UN peacekeepers operate in some of the most fraught regions across the globe. They stand between civilians and forces of violence, between crisis and peace. But peacekeeping has a problem: Sexual violence by UN peacekeepers ruins lives and undermines the trust peacekeeping requires to work effectively. Decades of attempts of reform have had limited impact because of the culture of impunity that pervades peacekeeping.

UNA-UK has launched a campaign - Mission Justice - which will establish the idea that sexual violence by UN Peacekeepers is a crime that requires a criminal response, and will push to make sure that states who are unable to prosecute perpetrators cannot contribute troops.

Keeping Britain Global

Everyone in the UK benefits from the international system

– from the protection of our rights, trade relationships that support our economy and global institutions that are committed to dealing with shared threats and challenges. UNA-UK believes now more than ever that Britain's national interest and the UN Charter's vision of a peaceful and more just world are one and the same. The Keeping Britain Global campaign focuses on five key connected areas:

Atrocity Prevention

The international community's prevention record of atrocities remains at a poor level, with calls for greater attention to the doctrine of "Responsibility to Protect" (R2P) even when it does not align with the strategic interests of the United Kingdom. As a permanent seat on the UN Security Council, UNA-UK continues to advocate for a cross-governmental approach to atrocity prevention, that incorporates R2P as a 'lens' to analyse policy in multiple policy areas. Peacekeeping

UN peacekeeping represents one of the most impactful and effective methods for maintaining peace and ensuring security across the world, with the United Kingdom having a commendable track record of providing troops despite of a reduction in the number in recent decades. Recent UNA-UK efforts have included endorsing a revised approach to effective peacekeeping missions by the British government.

Human Rights

Notable efforts concerning human rights violations have been made in tackling modern slavery, sex trafficking and the prevention of violence against women and girls. However, the UK has been notably silent on the human rights violations of its allies, causing criticism the international community. Recent UNA-UK recommendations have included the strengthening of human rights law that incorporates universal human rights protections.

Nuclear Disarmament

The creation of treaties, and international norms such as the Nuclear Proliferation Treaty has helped create a more stable global system that has regulated the proliferation of nuclear technology and the prevention of nuclear weapons falling into the wrong hands. However there continues to be little appetite for disarmament by co-signatories, including the UK. UNA-UK has concentrated efforts to encourage better diplomatic engagement and international dialogue regarding nuclear arms by the British government.

Arms Control

UK governments over the past few decades have understood the importance of the development and the adoption of the Arms Trade Treaty (ATT), showing leadership in driving its progress on the international stage. However, since its implementation in 2014, the UK continues to be a leading exporter of arms to countries with poor records such as Saudi Arabia. These actions undermine the ATT and jeopardises Britain's influence on matters concerning peace and security as a member of the P5. Recent UNA-UK reports have endorsed greater clarity and coherence when implementing the ATT.

Campaigning

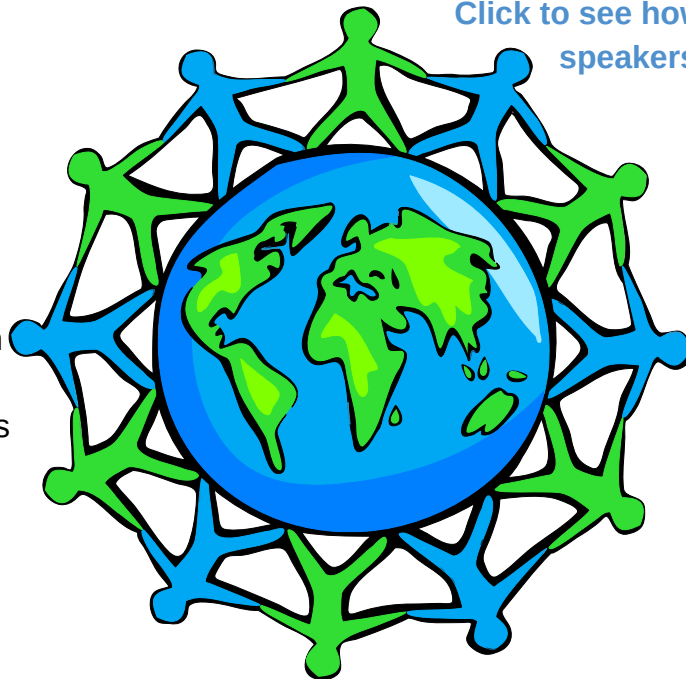

What will you do to support the United Nations?




What is your position on arms sales to Saudi Arabia and other human rights abusers?
